Ltd. ("PVPL"), has on 10th and 11th April 2018, purchased an aggregate of 599,150 shares in Refrigeration Electrical Engineering Corporation ("REE") for an aggregate cash consideration of approximately USD1.1 million.  As a result of the purchase, PVPL's shareholding in REE has increased from 24.46% to 24.65%.  The purchase was funded by internal resources, and the consideration was arrived at on a willing-buyer, willing-seller basis having regard to the prevailing market price. The closing market price of a REE share on the Ho Chi Minh Stock Exchange on 10th and 11th April 2018 was VND39,900 and VND38,500 respectively.
